FORMAT FOR SUBMISSION

ABSTRACT PREPARATION

Abstract for consideration should not be more than 200 words. Graphical abstracts are also allowed provided intended presentation it is clearly captured. Abstracts shall include the following elements:

Title

Authors

Affiliations

Corresponding author's email and telephone number

Background: A concise statement of the background

Objective(s) of study: Clearly state the purpose of study

Method/Methodology: A brief description of the critical approaches and instruments/apparatus used. For operational research, a brief description of data collection instrument and method, study design etc.

Results: A brief description of the critical output of the study. This may include graphs, spectra, charts, pictures, etc., with a minimum of text to illustrate the nature of the results.

Discussion: Discuss briefly the results and implied outcomes in comparison to similar studies reported in literature

Conclusions: Concise statement of the findings (positive, as well as negative), indicating future research directions or recommendations.

Keywords: List not more than FOUR keywords.

POSTER PREPARATION

Poster should be in **Portrait style**, 4 feet long and 3 feet wide (AO size = 1189mm x 841mm)

The poster should be organized to include the following elements:

Title

Authors

Affiliations

Corresponding author's email and telephone number

Background: A concise statement of the background

Objective(s) of study: Clearly state the purpose of study

Method/Methodology: Description of the apparatus, chemistry, samples, materials, etc. in some, but not overwhelming detail. For operational research, describe data collection instrument and method, study design etc but not too much detail.

Results: Graphs, spectra, charts, pictures, etc., with a minimum of text to illustrate the nature of the results.

Discussion: Discuss briefly the results comparing to literature

Conclusions: Concise statement of the findings (positive, as well as negative), indicating future research directions or recommendations.

References: List not more than SIX references

FULL PAPER

Instructions for Authors

Manuscripts should be submitted as a MS WORD file, neatly typed (Times New Roman font 12) with 3 cm margins and double-spaced lines. The full paper should be submitted. The article should not be more than 2500 words or 4 pages, including figures, tables and references.

The first page should contain the title of the article, authors' names (surnames and initials), followed by their affiliations. Author's name should not contain any prefix such as Dr., Prof., etc. or a postscript such as PhD, etc. An asterisk (*) should be added to the corresponding author's surname, just before the first letter. An abstract (not more than 200 words) and 4 - 6 keywords should be included at the beginning of the article.

The article should be divided into sections in the following order: Introduction, Methods/ Methodology, Results, Discussion, Acknowledgment and References. Figures and Tables should be inserted at the appropriate places in the article.
